

VILLAGE OF GAGETOWN
BY-LAW NO. 43
OFF-ROAD VEHICLE BY-LAW

A BY-LAW DESIGNATING PORTIONS OF ROADS WITHIN THE VILLAGE OF GAGETOWN ACCESSIBLE TO OFF-ROAD VEHICLES.

BE IT ENACTED BY THE Council of the Village of Gagetown pursuant to the authority granted under the Off-Road Vehicle Act, S.N.B. 1985, c.-0-1.5 and its amendments.

Definitions:

1. "Off-road vehicle" means all vehicles included in the definition of "off-road vehicle" as defined in the Off-Road Vehicle Act.

General Provisions:

2. Off-road vehicles may cross Court House Road at a 90° angle at a location as set out on a map attached to this By-Law as Schedule "A"
3. Off-road vehicles may cross Peters Road at a 90° angle at a location as set out on a map attached to this By-Law as Schedule "B"
4. Off-road vehicles may cross Mill Road at a 90° angle at a location as set out on a map attached to this By-Law as Schedule "C"
5. Off-road vehicles may cross Hector Street at a 60° angle at a location as set out on a map attached to this By-Law as Schedule "D"
6. Off-road vehicles may cross Chapman Lane at a 45° angle at a location as set out on a map attached to this By-Law as Schedule "E"
7. The person operating the off-road vehicle must bring the vehicle to a stop before entering upon the travelled portion of the roadway.
