This meeting will be held by staff of the Regional Service Commission 11 on behalf of the Village of Gagetown Council.

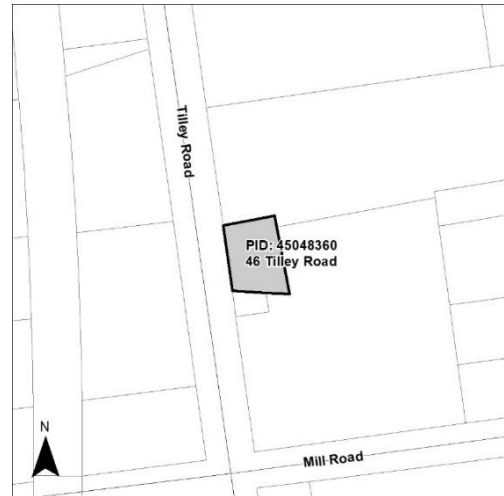
